Notes

1. **A unitholder has the right to appoint a person to represent the unitholder at the meeting(s) other than the management representatives named in this proxy.** This right may be exercised by inserting in the space provided the name of the other person the unitholder wishes to appoint. This other person need not be a unitholder.
2. To be valid, this proxy must be signed and deposited with AST Fund Solutions, LLC (“AST”) at 1 Toronto Street, 12th Floor, Toronto, ON, M5C 2V6. A properly completed form of proxy or your voting instructions by phone or via internet must be received at least 24 hours (excluding Saturdays, Sundays and public holidays) before the start of the meetings or any adjourned, postponed or continued meetings.
3. If the unitholder is an individual, this proxy must be executed exactly as the units are registered. For an individual unitholder who is voting on his or her own behalf, the unitholder has the option of voting by phone or via the internet, in addition to the option of sending a signed proxy to AST by mail, as described above. If a unitholder votes by phone or via the internet, the voting instructions received by AST over the phone or via the internet, as the case may be, will be deemed to be a valid proxy, and the unitholder voting by phone or via the internet acknowledges, agrees and represents that any applicable written or execution requirement related to proxy voting has been satisfied.
4. If the unitholder is a corporation, an authorized officer or attorney must execute this proxy. Evidence of authority may be required. If units are registered in the name of an executor, administrator or trustee, this proxy must be executed exactly as the units are registered. If the units are registered in the name of a deceased or other unitholder, the unitholder’s name must be printed in the space provided, the legal representative must sign this proxy with his or her name printed beside his or her signature, and evidence of authority to sign on behalf of the unitholder must be attached to this proxy.
5. If units are held by two or more unitholders, any one of them may vote the units, but if more than one of them are present or represented by proxy, all of these unitholders must vote the units together.
6. If this proxy is not dated in the space provided, it is deemed to bear the date on which it was mailed by CIBC Asset Management Inc. to the unitholder.
