Management Discussion of Fund Performance

Investment Objective and Strategies

Investment Objective: Renaissance Canadian Balanced Fund (referred to as the *Fund*) seeks to achieve long-term investment return through a combination of income and capital growth by investing primarily in a diversified portfolio of Canadian equity securities, investment-grade bonds, and money market instruments.

Investment Strategies: The Fund invests in a combination of equity and fixed income securities issued by governments or corporations. The Fund uses a bottom-up, fundamental approach to primarily invest in equity securities of high-quality companies, in combination with a strategic asset allocation strategy. The Fund may also diversify its holdings across different countries and geographical regions in an effort to manage the risks of the Fund.

Risk

The Fund is a Canadian equity balanced fund that is suitable for medium to long term investors who can tolerate low to medium investment risk.

For the period ended August 31, 2023, the Fund's overall level of risk remained as discussed in the simplified prospectus.

Results of Operations

The Fund's portfolio advisor is CIBC Asset Management Inc. (referred to as *CAMI*, the *Manager*, or *Portfolio Advisor*). The commentary that follows provides a summary of the results of operations for the period ended August 31, 2023. All dollar figures are expressed in thousands, unless otherwise indicated.

The Fund's net asset value decreased by 8% during the period, from \$128,062 as at August 31, 2022 to \$117,907 as at August 31, 2023. Net redemptions of \$17,341 were partially offset by positive investment performance, resulting in an overall decrease in net asset value.

Class A units of the Fund posted a return of 5.9% for the period. The Fund's primary benchmarks, the FTSE Canada Universe Bond Index and the S&P/TSX Composite Index (referred to as the *primary benchmarks*), returned 0.8% and 8.6%, respectively, for the same period. The Fund's return is after the deduction of fees and expenses, unlike the primary benchmark's return. See the section *Past*

Performance for the returns of other classes of units offered by the Fund.

The period was characterized by rapidly increasing interest rates and persistently high inflation. Despite this, strong employment numbers and rising wages contributed to robust consumer spending for most of the period. Adding to market uncertainty was China's post-pandemic recovery, which was slower than expected and weighed on prices for resources. The continuing conflict in Ukraine also led to concerns about resource markets, especially potash and grain.

Inflation remained well above central bank targets, leading to further interest-rate increases. The U.S. Federal Reserve Board (referred to as the *Fed*) raised interest rates by 3.0%, while the Bank of Canada raised interest rates by 2.5%. Futures markets were no longer pricing in any interest-rate decreases over the next 12 months, as consensus expectations leaned toward a soft economic landing, with inflation remaining elevated for some time.

Bond yields rose despite weaker economic and inflation data, as expectations of further interest-rate increases impacted markets. Both the U.S. and Canadian yield curves (which measure the difference between two-year and 30-year bond yields) inverted over the period, reflecting expectations that more restrictive central bank monetary policy could lead to a recession. In an inverted curve, short-term yields are higher than long-term yields.

Corporate bonds outperformed amid strong demand for higher-risk assets, lower new issuance supply and better-than-anticipated profitability. Still, corporate bonds faced significant volatility, particularly following the collapse of several U.S. regional banks. However, regulators, the U.S. treasury and the Fed acted quickly to reassure markets.

In the Fund's equity component, moderately overweight exposure to the gas subsector detracted from performance as Henry Hub gas prices fell by more than 65%. Stock selection in and a moderate overweight allocation to the consumer staples sector also detracted from performance, as did stock selection in and moderate underweight exposure to the industrials sector. Slight underweight exposure to information technology detracted from performance. The sector gained

by more than 50% as consumer confidence remained resilient and enthusiasm for artificial intelligence (referred to as *AI*) increased.

Individual detractors from performance included holdings in Dollar General Corp., TELUS International (CDA) Inc. and Tourmaline Oil Corp. Dollar General was affected by the deteriorating spending ability of low-income consumers, leading to slowing same-store sales. TELUS detracted as a result of unexpected cutbacks by several major customers. Tourmaline Oil Corp. detracted given the significant decline in gas commodity pricing.

Moderate underweight exposure to the utilities sector contributed to performance as this interest-rate-sensitive sector underperformed. Stock selection in and a moderate overweight allocation to the consumer discretionary sector also contributed to performance. A significant overweight allocation to health care contributed to performance, as did stock selection in and slight underweight exposure to communication services.

Individual contributors to performance included holdings in NVIDIA Corp., LVMH Moet Hennessy Louis Vuitton SE, Element Fleet Management Corp., DRI Healthcare Trust and Home Capital Group Inc. NVIDIA benefited from elevated demand for graphics processing units with the proliferation of AI. LVMH benefited from strong demand for its leather goods and luxury items.

Element Fleet Management executed on its multi-year cost savings program and focused on growth, with a significant post-pandemic backlog adding to market confidence. DRI Healthcare Trust delivered on a series of attractive royalty acquisitions. Home Capital Group benefited from a premium takeout bid from Smith Financial Corp.

Within the Fund's fixed income component, holdings in Government of Canada (1.75%, 2053/12/01 and 4.00%, 2041/06/01) and Province of Ontario (2.90%, 2046/12/02) detracted from performance. These bonds were negatively impacted by their long duration and rising bond yields.

Yield curve positioning contributed to performance, as the fixed income component had underweight exposure to the short-term end of the yield curve. U.S. treasury bond holdings contributed to performance as a result of interest-rate volatility. Overweight allocations to corporate and high-yield bonds also contributed to performance. The component's duration (a measure of interest-rate sensitivity) contributed to performance.

Individual contributors to performance included Mattamy Group Corp. (5.25%, 2027/12/15), Albertsons Cos. Inc. (4.88%, 2030/02/15) and GFL Environmental Inc. (4.00%, 2028/08/01). All three holdings benefited from narrowing credit spreads (the difference in yield between corporate and government bonds of similar maturity).

The Portfolio Advisor increased the Fund's exposure to the information technology with new equity holdings in CGI Inc. and Thomson Reuters Corp. These purchases were made to gain exposure to the growth potential from AI. Cineplex Inc. was added as the company continues to recover from pandemic lows and has significant upside from reducing its debt. A new bond holding in TELUS Corp. (4.95%, 2033/06/28) was added for its attractive yield and new issuance concession.

The Portfolio Advisor increased an existing equity holding in Alimentation Couche-Tard Inc. given its ability to grow revenues even in recessionary environment. Barrick Gold Corp. was increased for its gold exposure, a measure taken to hedge against a potential recession. An existing bond holding in Royal Bank of Canada (5.24%, 2026/11/02) was increased to benefit from the inverted yield curve and to increase yield.

The Portfolio Advisor eliminated an equity holding in Franco-Nevada Corp. in favour of Barrick Gold Corp. Holdings in Boralex Inc. and Fortis Inc. were sold to reduce the Fund's exposure to the interest-ratesensitive utilities sector. A Honda Canada Finance Inc. (4.87%, 2027/09/15) bond was eliminated, and the funds were redeployed into VW Credit Canada Inc. bonds to increase yield.

The Portfolio Advisor trimmed equity holdings in Bank of Montreal, The Bank of Nova Scotia and Royal Bank of Canada to increase the Fund's exposure to The Toronto Dominion Bank. The Fund's overall bank exposure was reduced amid increased risk of recession-related credit losses. A bond holding in Parkland Corp. (4.63%, 2030/05/01) was trimmed to reduce exposure to the high-yield sector and overall portfolio risk.

Recent Developments

Effective April 27, 2023, Bryan Houston was appointed Chair of the Independent Review Committee.

The COVID-19 pandemic and the Russia-Ukraine war have disrupted the global economy and financial markets in unprecedented and unpredictable ways. This has resulted in significant volatility and uncertainty in financial markets. It is unclear what further actions may be taken by governments and the resulting impact on global economies, businesses and financial markets. Inflation has increased in many markets across the globe, leading central banks to raise interest rates in order to counter rapidly rising prices. These factors may adversely affect the performance of the Fund. The Manager continues to monitor ongoing developments and the impact to investment strategies.

Related Party Transactions

Canadian Imperial Bank of Commerce (referred to as *CIBC*) and its affiliates have the following roles and responsibilities with respect to the Fund, and receive the fees described below in connection with their roles and responsibilities.

Manager, Trustee, and Portfolio Advisor of the Fund

CAMI, a wholly-owned subsidiary of CIBC, is the Fund's Manager, Trustee, and Portfolio Advisor. As Manager, CAMI receives management fees with respect to the Fund's day-to-day business and operations, calculated based on the net asset value of each respective class of units of the Fund as described in *Management Fees*.

The Manager pays the Fund's operating expenses (other than certain fund costs) in respect of the classes of units of the Fund (except Class O unit), which may include but are not limited to, operating and administrative costs; regulatory fees; audit, and legal fees and expenses; trustee, safekeeping, custodial, and any agency fees; and investor servicing costs and costs of unitholder reports, prospectuses, Fund Facts, and other reports, in exchange for the Fund paying a fixed rate administration fee (plus applicable GST/HST) to the Manager with respect to those classes of units. For Class O units, no fixed administration fee will be charged. The Manager pays the Fund's operating expenses (other than certain Fund costs) allocated to Class

O units of the Fund. The fixed administration fee payable by the Fund, may, in any particular period, exceed or be lower than the expenses we incur in providing such services to the Fund.

As Trustee, CAMI holds title to the Fund's property (cash and securities) on behalf of its unitholders. As Portfolio Advisor, CAMI provides, or arranges to provide for, investment advice and portfolio management services to the Fund. CAMI also compensates dealers in connection with their marketing activities regarding the Fund. From time to time, CAMI may invest in units of the Fund.

Distributor

Dealers and other firms sell units of the Fund to investors. These dealers and other firms include CAMI's related dealers such as the CIBC Investor's Edge discount brokerage division of CIBC Investor Services Inc. (referred to as *CIBC ISI*), the CIBC Imperial Service division of CIBC ISI, and the CIBC Wood Gundy division of CIBC World Markets Inc. (referred to as *CIBC WM*). CIBC ISI and CIBC WM are wholly-owned subsidiaries of CIBC.

CAMI may pay sales commissions and trailing commissions to these dealers and firms in connection with the sale of units of the Fund. These dealers and other firms may pay a portion of these sales commissions and trailing commissions to their advisors who sell units of the Fund to investors.

Brokerage Arrangements and Soft Dollars

The Portfolio Advisor or any portfolio sub-advisors make decisions, including the selection of markets and dealers and the negotiation of commissions, with respect to the purchase and sale of portfolio securities, certain derivative products and the execution of portfolio transactions. Brokerage business may be allocated by the Portfolio Advisor or any portfolio sub-advisor(s) to CIBC WM and CIBC World Markets Corp., each a subsidiary of CIBC. CIBC WM and CIBC World Markets Corp. may also earn spreads on the sale of fixed income securities, other securities, and certain derivative products to the Fund. A spread is the difference between the bid and ask prices for a security in the applicable marketplace, with respect to the execution of portfolio transactions. The spread will differ based upon various factors such as the nature and liquidity of the security.

Dealers, including CIBC WM and CIBC World Markets Corp., may furnish goods and services, other than order execution, to the Portfolio Advisor or any portfolio sub-advisor(s) when they process trades through them. These types of goods and services for which the Portfolio Advisor or a portfolio sub-advisor may direct brokerage commissions are research goods and services and order execution goods and services, and are referred to in the industry as "soft-dollar" arrangements. These goods and services received through soft dollar arrangements assist the Portfolio Advisor or any portfolio sub-advisor(s) with investment decision-making services for the Fund, or relate directly to the execution of portfolio transactions on behalf of the Fund. As per the terms of the portfolio advisory agreement and portfolio sub-advisory agreements, such soft dollar arrangements are in compliance with applicable laws.

During the period, the Fund paid brokerage commissions and other fees of \$9,329 to CIBC WM and \$59 to CIBC World Markets Corp. Spreads

associated with fixed income and other securities are not ascertainable and, for that reason, cannot be included when determining these amounts.

Fund Transactions

The Fund may enter into one or more of the following transactions (referred to as the *Related Party Transactions*) in reliance on the standing instructions issued by the Independent Review Committee (referred to as the *IRC*):

- invest in or hold equity securities of CIBC or issuers related to a portfolio sub-advisor;
- invest in or hold non-exchange-traded debt securities of CIBC or an issuer related to CIBC, with terms-to-maturity of 365 days or more, issued in a primary offering and in the secondary market;
- make an investment in the securities of an issuer for which CIBC WM, CIBC World Markets Corp., or any affiliate of CIBC (referred to as a *Related Dealer* or the *Related Dealers*) acts as an underwriter during the offering of the securities or at any time during the 60-day period following the completion of the offering of such securities (in the case of a "private placement" offering, in accordance with the Private Placement Relief Order and the policies and procedures relating to such investment);
- purchase equity or debt securities from, or sell them to, a Related Dealer, where it is acting as principal;
- undertake currency and currency derivative transactions where a related party is the counterparty;
- purchase securities from or sell securities to another investment fund or a managed account managed by the Manager or an affiliate (referred to as *inter-fund trades* or *cross-trades*); and
- engage in in-specie transfers by receiving portfolio securities from, or delivering portfolio securities to, a managed account or another investment fund managed by the Manager or an affiliate, in respect of a purchase or redemption of units of the Fund, subject to certain conditions.

At least annually, the IRC reviews the Related Party Transactions for which they have issued standing instructions. The IRC is required to advise the Canadian securities regulatory authorities, after a matter has been referred to or reported to it by the Manager, if it determines that an investment decision was not made in accordance with conditions imposed by securities legislation or the IRC in any Related Party Transactions requiring its approval.

Custodian

CIBC Mellon Trust Company is the custodian of the Fund (referred to as the *Custodian*). The Custodian holds cash and securities for the Fund and ensures that those assets are kept separate from any other cash or securities that the Custodian might be holding. The Custodian also provides other services to the Fund including record-keeping and processing of foreign exchange transactions. The fees and spreads for the services of the Custodian are paid by the Manager. CIBC owns a 50% interest in the Custodian.

Service Provider

CIBC Mellon Global Securities Services Company (referred to as *CIBC GSS*) provides certain services to the Fund, including securities lending, fund accounting and reporting, and portfolio valuation. Such servicing fees are paid by the Manager. CIBC indirectly owns a 50% interest in CIBC GSS.

⁸ The portfolio turnover rate indicates how actively the portfolio advisor and/or portfolio sub-advisor manages the portfolio investments. A portfolio turnover rate of 100% is equivalent to a fund buying and selling all of the securities in its portfolio once in the course of the period. The higher a portfolio turnover rate in a period, the greater the trading costs payable by a fund in the period, and the greater the chance of an investor receiving taxable capital gains in the year. There is not necessarily a relationship between a high turnover rate and the performance of a fund.

Management Fees

The Fund pays CAMI an annual management fee to cover the costs of managing the Fund. Management fees are based on the Fund's net asset value and are calculated daily and paid monthly. Management fees are paid to CAMI in consideration for providing, or arranging for the provision of, management, distribution, and portfolio advisory services. Advertising and promotional expenses, office overhead expenses, trailing commissions, and the fees of the portfolio sub-advisor are paid by CAMI out of the management fees received from the Fund. The Fund is required to pay applicable taxes on the management fees paid to CAMI. Refer to the simplified prospectus for the annual management fee rate for each class of units.

For Class O units, the management fee is negotiated with and paid by, or as directed by, unitholders or dealers and discretionary managers on behalf of unitholders. Such Class O management fee will not exceed the Class F unit management fee rate.

The following table shows a breakdown of the services received in consideration of the management fees, as a percentage of the management fees collected from the Fund for the period ended August 31, 2023. These amounts do not include waived fees or absorbed expenses.

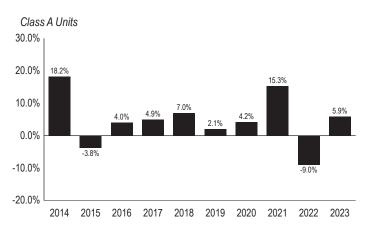

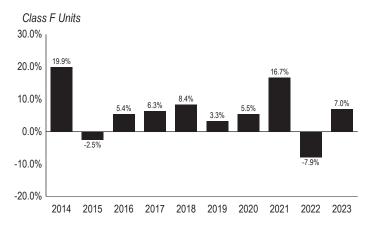
