#### **Investment objective**

**Renaissance Global Infrastructure** Currency Neutral Fund (referred to as the Fund) seeks long-term capital growth primarily through exposure to a global equity fund that invests primarily in securities of companies located throughout the world that are involved in, or that indirectly benefit from, the development, maintenance, servicing, and management of infrastructures (referred to as the *Underlying Fund*). The Fund will attempt to reduce its currency exposure to non-Canadian dollar currencies by implementing a currency hedging strategy.
